We welcome Gerrie, Audrey, and Debbi who have all served on the board in prior years and are rejoining the board for 2017.

Sonia was our 2016 Vice President and took over the President position when it became vacant in April 2016. She has done a great job leading the monthly meetings with sensitivity to speakers and time limitations. Lynn has been our Treasurer for the last two years and has organized record keeping for that position. For the last year, she has edited and published *The Rolando Park Reporter* and updated our website. She led efforts to obtain donations to purchase new Neighborhood Watch signs and solicit volunteers to install them.

Kathryn and Gerrie worked together on the 2014-15 San Diego Foundation grant awarded to RPCC. Kathryn is a 2016 Board Member-at-Large. She initiated RPCC Pop-ups to encourage neighbors to join the RPCC or to keep them informed of important issues. Mini-Dorm Ordinance

On Monday, November 14, the San Diego City Council voted 6 to 3 to end the development of mini-dorms in College Area neighborhoods near SDSU.

The legislation includes limiting the number of bedrooms in new construction with stricter parking regulations and there will be greater enforcement for homeowners who violate the rules. Also, the maximum fine for code violations will be increased to \$10,000 a day to be paid by the homeowner, not the tenant.

Why does this matter to the Rolando Park community? Unfortunately, the ordinance was *only* approved for the College Area, even though the Eastern Area Community Planning Commission (EACPC), Councilmember Cole, and Councilmember Emerald requested that it also include all communities in EACPC. Without the protection of the ordinance, those of us in Eastern Area communities (Rolando Park, Rolando, El Cerrito Heights, Redwood Village, Oak Park, and Webster) could start to see minidorms.

EACPC is discussing passage of the mini-dorm ordinance and its exclusion of our area with Councilmember Emerald's office. Thus far, the response has been that "the Eastern Area communities need to start advocating for their neighborhoods to be included in the ordinance sometime after December 12 when an email/letter writing campaign to their Councilperson would certainly be in order." Councilmember Cole is taking the lead to include Eastern Area communities in the ordinance.

The current ordinance will become law and take effect sometime in January 2017 after the Second Reading. As a member of EACPC, RPCC is making inclusion of Eastern Area communities in the ordinance a top priority for 2017. Please attend our monthly meetings to ensure that you voice your opinion (pro or against the ordinance) and stay updated on the latest status for our community.

In the meantime, should you suspect that a recent home sale is morphing into a minidorm (against single-family zoning codes), please contact Code Compliance to have them reconfirm. If someone is building an addition to their home and it is permitted, then no harm no foul. As a third-party, they will investigate and take proper action. Vista Grande/Marlowe Intersection

More than two years ago, residents requested that the Vista Grande/Marlowe intersection, which is the entrance to Rolando Park Elementary, install two additional stop signs to make it a four-way stop and a traffic study was requested. The traffic study concluded that the intersection did not qualify for a four-way stop, but instead, recommended that traffic calming radar display signs that display vehicle speed be installed. Two of these speed signs cost approximately \$20,000. To date, funding for these radar signs is still not available and there has not been any indication that it would be in the near future. At the request of residents, RPCC decided to pursue an alternative process. Volunteers collected more than 130 signatures in the community, including many parents with children attending Rolando Park Elementary and on October 11, we presented our case to Eastern Area Community Planning Commission (EAC-PC) who voted unanimously to convert this intersection to a four-way stop. The approval letter from EACPC was forwarded to Councilmember Myrtle Cole and we are waiting for an installation date.

Many thanks to all of the community volunteers who supported this cause and made it happen.

Rolando Park Elementary School

Good things are happening at Rolando Park Elementary, under the new leadership of Principal Anthony DeLuca. On October 28, after a three-year absence, the school had a Halloween Carnival. The parking lot was packed! The atmosphere was electric, with music playing, lots of booths, costumes, and a cake walk. Approximately 300 people attended and brought in about \$1800, to be used for a variety of student needs.

A Western Day Barbecue was held on November 4, with a showing of around 100 parents, impressive for a small school during the work day. The students were thrilled to share burgers and dogs with them!

Every Friday begins with a Coffee with the Principal session at 8:00 in the auditorium, when parents and guardians have a chance to visit and ask questions or get information about happenings at school. Next, they go to their children's classrooms and read to the students for 30 minutes, finishing up back in the auditorium to share the experience or ask further questions.

In an interview, Pre-K teacher Alma Tidwell shared that Mr. DeLuca is passion-

ate about the students' education and well being, and is very supportive of the teachers. The school is now well organized and she feels that he has turned the school around 360 degrees. She said that Principal DeLuca stays on top of the latest in education, sharing information with the teachers at math and literacy meetings.

Best wishes for continued revival of Rolando Park Elementary! Every neighborhood is made better when its local school has a good reputation!


