# Radar V-Calming Signs

- 2017 traffic studies showed traffic calming warranted at three locations:
  - $\circ$  Rolando Blvd
  - $\odot$  Vista Grande between Racine and Celia Vista
  - $\odot$  Aragon between Celia Vista and University
- Funding secured last year
- Community outreach to affected property owners completed and work orders prepared by Traffic Engineering and submitted to Streets Division in September
- Installation now dependent on Streets Division schedule
