From Nordine: Reacted to "can we get a sign th..." with 👍

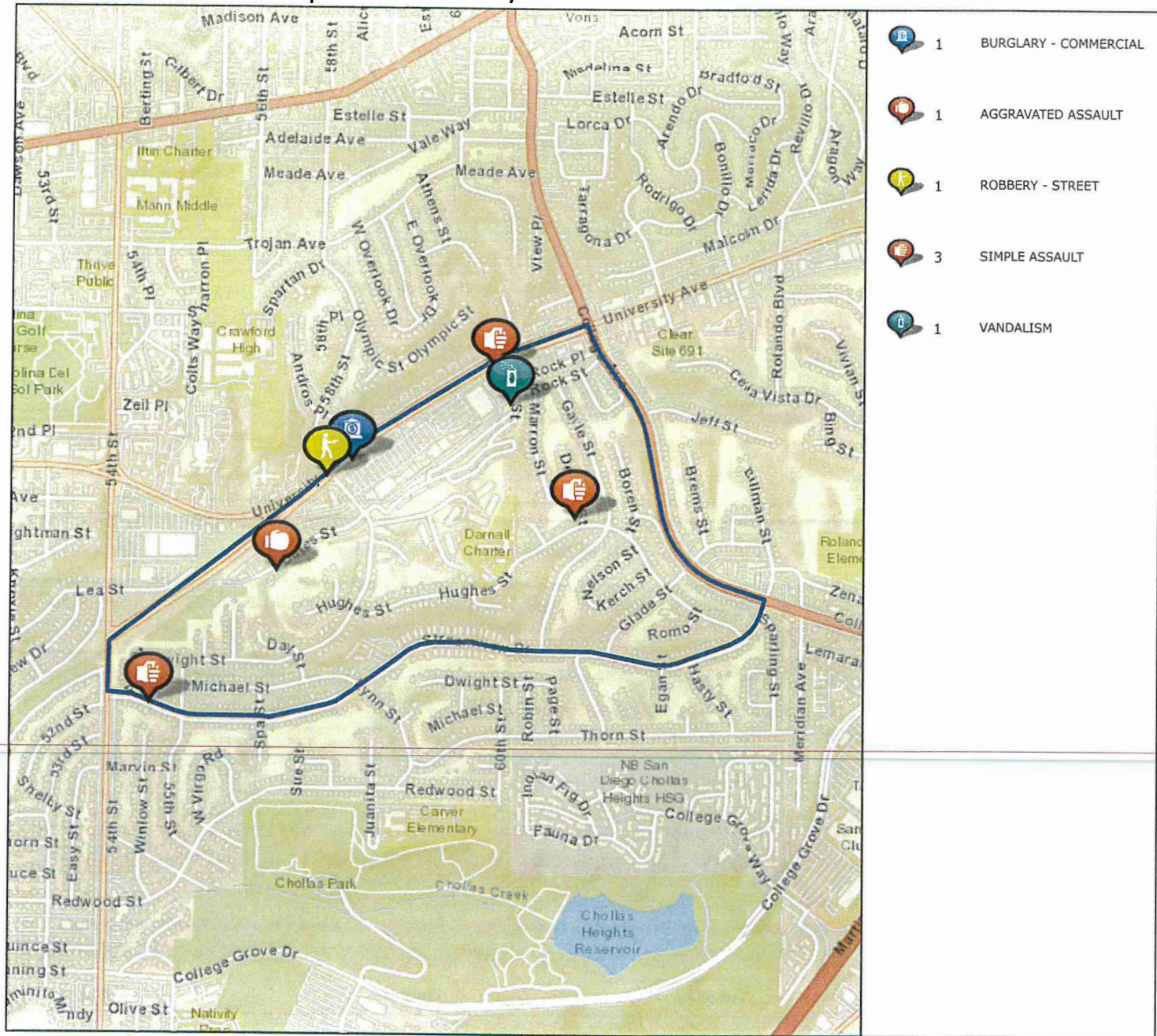
From Michelle Alexander: Replying to "can we get a sign th..."

From Nordine: Reiterating, consider zig zag planters as shown in the link. Thanks Jennifer.

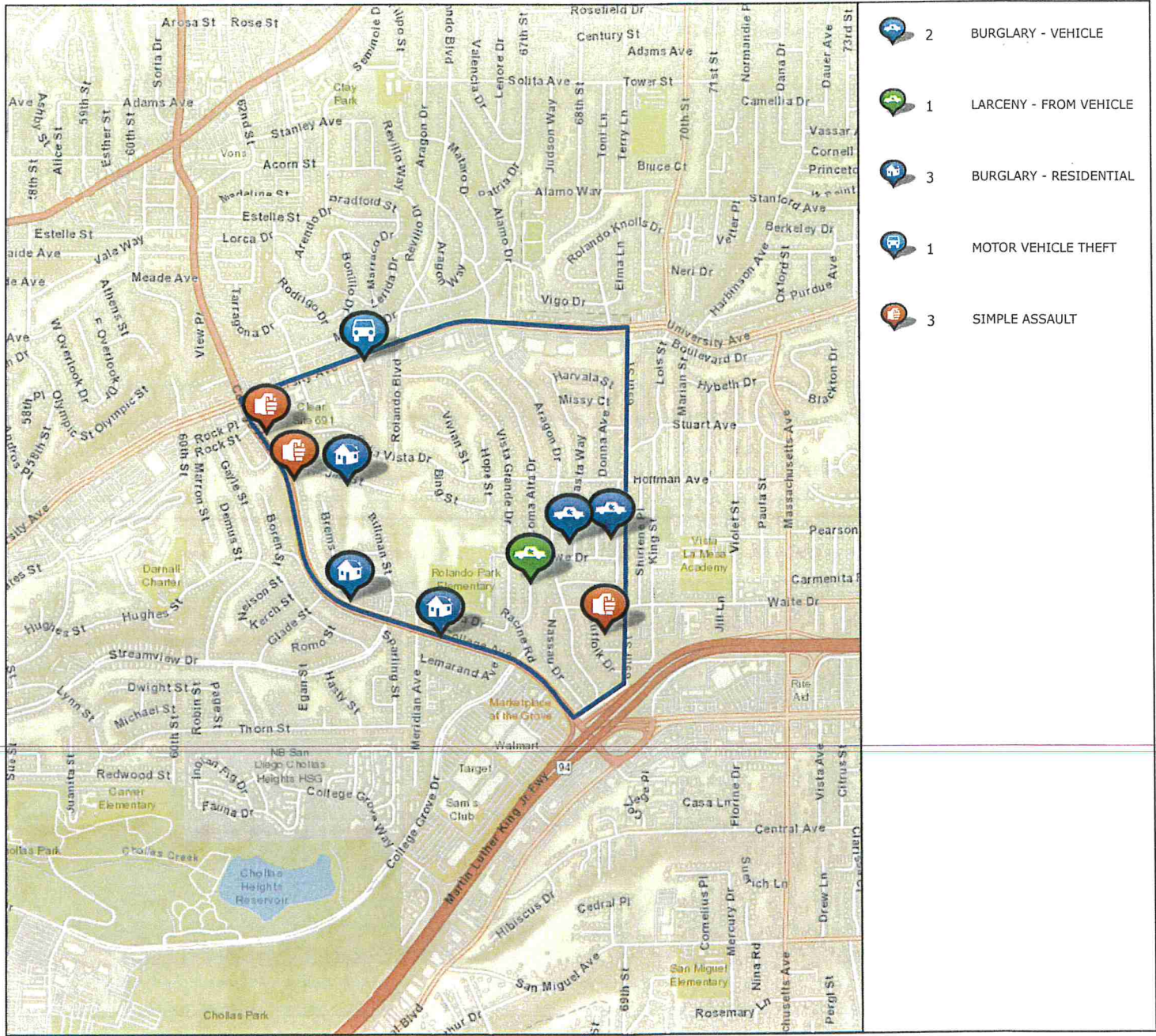
From Nordine: Thanks Sonia.

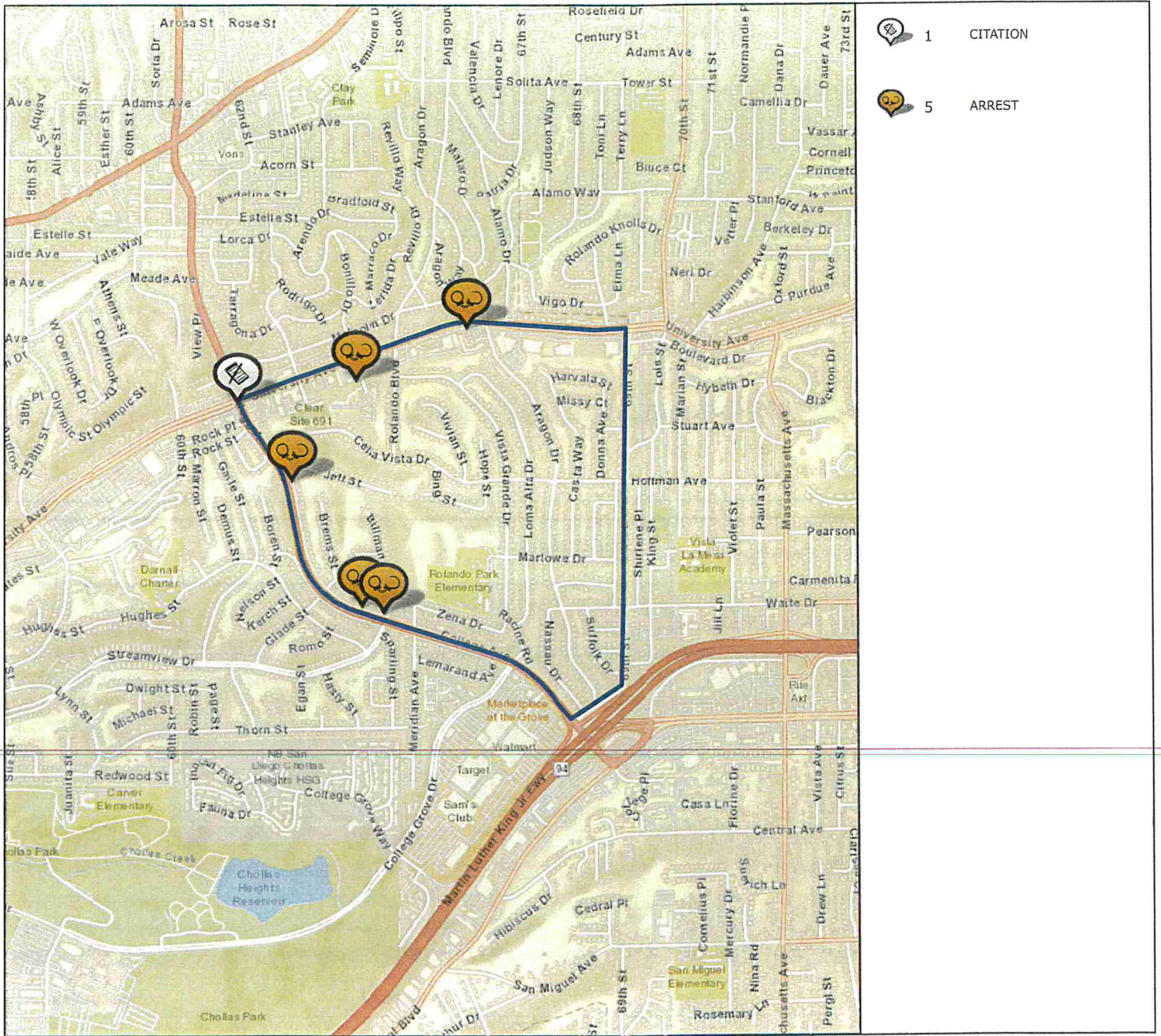
