Meeting called to order at 7:02 pm by Co-President Sonia Lang.

Treasurer's Report

Sonia reported that thus far in February 2025, 12 members have renewed their memberships with 6 new members for \$228 in membership dues and \$254.75 in donations.

Nonagenda Public Comments

Gerrie expressed interest in forming a fire safe council with neighbors in Rolando Park and Redwood Village, citing past experiences with wildfires and the need for better advocacy with the city. She has been in touch with the Fire Safe Council for Kensington and is seeking help from Roberto to improve her advocacy efforts. Gerrie also mentioned her efforts to mitigate brush on city property below her house.

Representatives' Reports

- Officer Josh Cummings, Community Relations Officer, SDPD Officer Cummings reported on the successful cleanup at the Chollas Parkway, but noted a recent vandalism incident at the SDG&E project site. He also discussed the impact of Proposition 36 on the homeless population and the city's budget deficit, which is expected to affect overtime and hiring.
- Fatima Maciel, Mayor Todd Gloria's office Fatima discussed the city's budget priorities and the increase in parking meter rates. (A separate report from Fatima is attached.)
- Roberto Marin, City Councilmember Sean Elo-Rivera's office Roberto highlighted the successful
 cleanup at Chollas Parkway, the city's budget deficit, and the proposed shelter options. He also
 mentioned the upcoming repaving of Hughes Drive in March and the possibility of a presentation by
 Tony Tosca on brush abatement.
- Sam Gonzalez, 39th Senate District, State Senator Dr. Akilah Weber Pierson Sam had to leave early, but provided a written report (attached).

Community Updates

- Redwood Village Bettina
 - February 8: First of four Streamview Dr Dumpster Days for 2025: 2 dumpsters filled in 2 hours; thank you volunteers (Lynn, Roberto D9, John, Peter, Joyce, Vickie, Loretta, Bettina) & D9 Council for providing dumpsters and outreach.
 - Hughes St repaving to begin in March beware of additional traffic delays; continued sewer pipe replacement work on Glade St, also affecting traffic and parking on Boren St, Boren St cul-de-sac, College Ave frontage, and Perique.

- o Chollas Pkwy abatement and major clean up last week, with major cleanup taking place this week, red curbing of most of the area coming soon.
- o Position available for RV resident/business owner on EACPC.
- o City has approved permit for construction of 15-unit apartment building on Boren St cul-de-sac.
- Rolando Park Lynn discussed the upcoming March election of board officers, the need for more volunteers, the successful Streamview Dumpster Day on February 8, new mural art on University, the upcoming EACPC meeting and a water shutoff on 69th St later this week. Lynn's updates are attached.

Presentation: Commission on Police Practices Overview

Yesmeen Obeid, the Community Engagement Coordinator at the Commission on Police Practices, discussed the history and role of the Commission in police oversight in San Diego. Established in 1985, the Commission has evolved over the years, with its latest version, the Commission on Police Practices, being a direct result of Measure B passed by San Diego voters in 2020. The Commission is an independent body from the mayor, police chief, police department, and city attorney, with its own attorneys and investigators. It has three main powers: investigative, review, and auditing. The Commission's mission is to hold law enforcement accountable to the community, increase community trust in law enforcement, and ensure safety for both the community and law enforcement. Yasmeen also explained the Commission's role in evaluating complaints against the San Diego Police Department, reviewing policies, practices, trainings, and protocols, and making recommendations for change. The Commission is also working towards the ability to conduct independent investigations into officer-involved shootings and other significant incidents.

Yasmeen also discussed the composition and appointment process of the community members in the Commission on Police Practices. The Commission consists of 25 members, including representatives from different city council districts, low to moderate income areas, and youth. She also explained the role of the Commission in reviewing complaints and making recommendations to the police department. The presentation ended with a discussion on the funding for the Commission and the process for serving on the Commission. There are currently nine openings.

Yasmeen's presentation is attached.

Lynn gave brief updates on 2025 Priorities and thanked everyone who participated in the annual priority survey. More than 30 responses were received. The March meeting will focus on all of the survey results and responses, but the three top priorities are:

- 1. Completion of the Rolando Park Gateway
- 2. Streamview Dr. illegal dumping
- 3. Traffic calming in Rolando Park

Meeting adjourned at 8:21 pm.

Report from Mayor Todd Gloria's Office Parking Meter Rates Increase in the City of San Diego:

- Parking meters will cost \$2.50 effective January 31, 2025.
- There are 5,332 parking metered spaces in the city, located in the neighborhoods of Downtown, Uptown, Mid-City and Pacific Beach
- Meter fees help fund maintenance of transportation infrastructure like streets, sidewalks and streetlights in areas with parking meters.
- It's been at least 20 years since parking meter fees have been increased in the City of San Diego.
- Even with the rate increase, San Diego's parking meter fees remain among the lowest in the state of California. Oakland's parking meters cost up to \$4 an hour, Los Angeles charges up to \$6 an hour, and San Francisco's meters cost up to \$11.
- Rates will not change for waterfront parking meters operated by the Port of San Diego, which are already set at \$2.50 an hour.

City of San Diego Identifies Safety Improvements for High Crash Locations:

- In order to improve traffic safety conditions and help protect pedestrians, the City of San Diego's Traffic Engineering team has recommended improvements for seven locations with high injury and fatal crashes in calendar year 2023.
- The High Crash Locations list and recommended safety improvements are part of an annual engineering process and the result of a year-long evaluation completed by the Transportation Department.
- The seven locations identified through the 2023 High Crash Locations analysis include five intersections and two street segments:
 - Art Street at El Cajon Boulevard (D9)
 - Kurtz Street at Rosecrans Street (D2)
 - Miramar Road at Nobel Drive (D6)
 - Briarwood Road at Paradise Valley Road (D4)
 - Pacific Highway at Taylor Street (D2)
 - El Cajon Boulevard from 63rd Street to Choctaw Drive (D9)
 - Market Street from 26th Street to 27th Street (D8)
- Traffic engineering teams are now in the process of designing and scheduling work for these safety improvement projects.
- Many of the safety improvements will be installed by City crews through quick build projects, but some must be completed through the City's Capital Improvement Program

and will require additional funding to implement.

City of San Diego Encourages Flood Preparedness and Prevention:

- The City of San Diego is taking proactive steps to ensure the safety of residents living in floodplain areas by distributing educational flyers with vital information on how to prepare for potential flooding.
- The informational brochures, which will be sent to about 10,000 residents who live in or own property in a floodplain, contain essential guidelines on emergency preparedness, evacuation plans, flood insurance and other critical flood-related resources.
- The Stormwater Department is working on two Capital Improvement Projects:
 - The Jamacha Drainage Channel Upgrade, which focuses on improving stormwater infrastructure to enhance flood protection and environmental resilience.
 - The Beta Street Storm Drain Improvements project, which focuses on upgrading aging stormwater infrastructure to enhance drainage capacity and reduce flood risks in the surrounding area.

City of San Diego Welcomes 2025 Genesis Invitational Golf Tournament to Torrey Pines:

- The City of San Diego announced that the world-famous Torrey Pines Municipal Golf Course will step forward to host the PGA TOUR's 2025 Genesis Invitational golf tournament typically held at The Riviera Country Club in Los Angeles.
- The PGA TOUR identified Torrey Pines as an ideal alternative venue to host The Genesis Invitational due to the course's time-tested ability to host major golf tournaments, its reputation as a challenging golf course for the world's best players and its proximity to The Riviera Country Club, located in Pacific Palisades.
- The Genesis Invitational will take place on the South Course at Torrey Pines from Thursday, Feb. 13 to Sunday, Feb. 16 with a field of 72 of the best players on the PGA TOUR.
- The event is hosted by TGR Live with the support of the Century Club of San Diego, and a portion of the proceeds will be used to aid the residents of Los Angeles.



- Must submit official high school transcript.
- Must complete application form including short essays.
- Must be able to commit to the scheduled sessions.

Program Dates:

- **Session #2:** May 28, 2025

- **Session #4**: July 30, 2025
- **Session #5:** August 27, 2025
- Session #6: September 24, 2025

You must submit your application by March 1, 2025 to be considered. Upon admission to the program, students must submit a participating agreement. - Volunteer sign-up sheet at the table by the entrance; will have a online volunteer form later this week.


Vacant Board Positions

- Secretary Keeps records of all Council and Board meetings and maintains historical records.
- Treasurer Collects dues, maintains the membership list, handles banking, and disburses funds as authorized by the Board. The treasurer maintains financial records, provides financial reports to the Board and the members, and is responsible for completing reports and paperwork required of the RPCC.

Commission on Police Practices



What is the CPP?

The Commission on Police Practices (CPP) is an investigatory body of the City, independent of the Mayor, Police Chief, and Police Department that has investigatory, review and auditing powers.

Commission on Police Practices

Mission

To hold law enforcement accountable to the community and to increase community trust in law enforcement, resulting in increased safety for both the community and law enforcement.





Purpose

- Provide independent <u>community oversight</u> of the San Diego Police Department (SDPD).
- Evaluate complaints against the SDPD sworn personnel.
- Evaluate and <u>review SDPD policies</u>, practices, training, and protocols, and make recommendations for changes.
- <u>Investigate</u> officer-involved shootings, in-custody deaths, deaths resulting from interaction with a police officer, and other significant incidents involving SDPD.



Composition

The Commission on Police Practices (CPP) is composed of 25 community volunteers:

- Nine district-specific representatives
- Nine at-large representatives
- Five low-to-moderate income area representatives
- Two youth representatives, ages 18-24



Qualifications

- Must qualify for the position you're applying for
- Must live in the City of San Diego
- Must not be a current City of San Diego employee
- <u>Must not</u> be a current or former law enforcement employee in the county of San Diego
- <u>Must not</u> be an immediate family or household member of a current or former law enforcement employee in the county of San Diego
- Must pass the six exceptions in the criminal background check



Criminal Background Exceptions

- 1. Malfeasance
- 2. Felony conviction and on parole, post-release community supervision, or mandated supervision
- 3. Found in violation of:
 - a. Misuse of a public position for personal interests
 - b. Misuse of City records
 - c. Confidentiality or City employee privacy
- 4. Convicted of a violent crime against a government employee or official
- 5. Registered sex offender
- 6.Incarcerated



Meetings & Commitment

The Commission on Police Practices (CPP) holds regularly scheduled meetings on the first & third Wednesdays of the month from 4:30-7:30 pm.

Other responsibilities:

- Committees
- Case review
- Trainings

Hours ~ 10-30 hours per month

- 1. Get nominated
- 2. Complete the Commission Application
- 3. Accept your nomination in writing
